Millage Rate is one thousandths (1/1000) - mathematically figured by moving the decimal point over 3 digits to the right (EX: 31.65 becomes 0.03165)

Procedure to estimate tax bill:

Millage Rate (divide by) Thousand (then multiply by) Taxable Value (to equal) Tax Amount (multiply by) appropriate Adm Fee % (to equal) = Tax Bill Amount

EXAMPLE:

$$40.5519 / 1000 * 50,000 = 2,027.60 * 1.01 = 2,047.88$$
