# RESOLUTION TO APPROVE ACQUISITION OF REAL PROPERTY AND MATTERS RELATED THERETO

WHEREAS, the Village desires to acquire real property located at 11537 S. Leelanau Hwy, Empire, Michigan 49630 for a Village Office (the "Property"); and

WHEREAS, the Village has negotiated with the owner of the Property for the sale of the Property to the Village and the purchase of the Property by the Village for the sum of \$480,000; and

WHEREAS, it is necessary and in the best interest of the Village to enter into a Real Estate Purchase and Sale Agreement for the Village to acquire the Property on certain terms and conditions as set forth in the Purchase Agreement; and

### NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

1. The Village Council hereby approves the acquisition of the Property for the sum of \$480,000 on the terms and conditions set forth in the Purchase Agreement including payment

of the purchase price and related costs for the acquisition of the Property, as more particularly described in the Purchase Agreement.

- 2. The Village Council hereby authorizes and directs the Village President to execute and deliver the Purchase Agreement and any and all related closing documents necessary for the acquisition of and closing on the Property with such changes as are deemed necessary and in the best interest of the Village in consultation with the Village Attorney and Mika Meyers PLC, as special legal counsel to the Village relating to the acquisition of the Property.
- 3. It is reasonably expected that the Village has or will advance funds from monies on hand in the Village's general fund in an estimated amount of \$5,000.00 as an earnest money deposit.
- 4. All resolutions or parts of resolutions in conflict herewith are hereby rescinded.
