



Summary

- **Traveling, family, and public service. 1:53**
 - Douglas Frank shares his passion for traveling the country and speaking to groups, having visited 46 states and 800 counties in the past year.
 - Frank's wife supports his calling, despite the time he spends away from home, and his children are involved in his work, with his oldest daughter Nellie being his "best friend on the planet."
- **Election fraud in Pennsylvania. 4:11**
 - Douglas Frank reveals a team of six found evidence of fraud in Pennsylvania's 2015 election, including 50,000 people added to voter rolls and removed after the election.
 - Frank obtained logs showing the same organization logged in and out of ballots, raising suspicions of fraud.
 - Douglas Frank claims that the Hillary Clinton campaign had login credentials to the Pennsylvania voter database in 2015, and that 30 non-government organizations also had access to the voter rolls.
 - The Pennsylvania legislature threw out their entire state voter rolls and hired a firm to rebuild them in time for their spring election after Douglas Frank showed them evidence of corruption.
 - Douglas Frank is frustrated with the lack of action from Pennsylvania officials regarding election fraud allegations.
 - Frank believes that the Supreme Court and legislatures are corrupt, leaving him feeling despondent.
- **Election fraud and personal background. 12:38**
 - Douglas Frank shares his experience of discovering election fraud in Pennsylvania and meeting Mike Lindell, who filmed a movie about him.
 - Mike Lindell told Douglas Frank that everything he's doing is paid for out of his own money, and some people in the movement are charging a lot of money to do what they're doing.
 - Dr. Frank is a retired scientist with 40 years of experience modeling elections and epidemics, and he feels called to use his skills to help save his country.
 - Dr. Frank is passionate about his work and grateful for the opportunity to use his talents for a higher purpose, and he is delighted to be working with Ron every day.
- **Election security and civic responsibility. 17:01**
 - Douglas Frank claims that a team of data people he worked with in Georgia are equipped to help him "kick some butt" in the state, and he plans to discuss how in a minute.
 - Frank references the Holderman report, which was paid for by the Hillary Clinton campaign, and highlights the inconsistency in the Democrats' complaints about election security now that it's the Republicans who are complaining.
 - Douglas Frank expresses anger at President Trump's phone call with Raffensperger, believing he was set up and making unsubstantiated claims.
 - Frank outlines a 7-step process to evaluate claims and avoid appearing like "conspiracy wing nuts."

- Douglas Frank emphasizes the importance of self-governance and warns against complacency in politics, citing Plato's quote about being governed by inferiors.
- Frank shares a personal story about a recent event in Wisconsin where he spoke to a crowd of 200 people, highlighting the need for action and self-governance.
- **The importance of having "big stones" in spiritual battles. 24:17**
 - Douglas Frank shares a humorous anecdote about a woman who prayed for him during a speaking event, asking God to give him "big stones" to fight against the lies of elections.
 - Frank reflects on the story of David and Goliath, noting that the problem wasn't Goliath, but rather the lack of faith and courage among the Israelites.
- **Protecting liberty through local elections. 27:06**
 - Douglas Frank urges listeners to stand up for truth and defend themselves, citing examples from around the country.
 - Douglas Frank: We've given up protecting the ballot box, leading to loss of liberty.
- **Fixing US elections by localizing control. 30:39**
 - Douglas Frank emphasizes the importance of local control in elections, citing his personal experience voting in a precinct and advocating for a return to that system.
 - Frank, an engineer, expresses distrust of electronic voting machines due to their centralized control and potential for manipulation, suggesting a leash-like approach to local control in elections.
 - Douglas Frank emphasizes the importance of paper ballots and local control in elections, citing examples from Pennsylvania and other states.
 - Frank shares his personal journey of learning how to take back elections through grassroots efforts and gathering wisdom from various individuals and organizations across the country.
 - Douglas Frank emphasizes the importance of getting connected and learning from past mistakes in the fight against election fraud.
 - He recommends connecting with organizations such as Cause of America and VoterGA, and encourages listeners to get organized and take action.
- **Local election reform strategies. 38:52**
 - Douglas Frank emphasizes the importance of having a team for election integrity, including a data person, promoter, recruiter, researcher, strategist, and archivist.
 - He provides an example of how a county in Wisconsin successfully implemented paper ballots after being attacked by ransomware, demonstrating the importance of localized strategies for election integrity.
 - Douglas Frank shares his experience in building a movement in Shasta County, California, where they successfully transitioned to paper ballots.
 - Frank emphasizes the importance of building a movement before going public with evidence, citing the **example of Wyoming's election results.**
- **Election fraud and local activism. 43:02**
 - Douglas Frank presents evidence of 350 cases of fraud to county commissioners, including cases of people voting after death and those who moved to another state.
 - Frank confronts county officials with unassailable cases of fraud, leading to two commissioners giving up their ballots in the next election.
 - Douglas Frank shares a personal story about a grandma who resigned from a county commission due to the commission's handling of an election, and how this led to a public movement and the election of more commissioners.
 - The local team conducted research and successfully convinced the county to not renew their Dominion contract, saving them \$250,000, and later got rid of their electronic poll books, saving them even more money.
 - Dr. Frank highlights the importance of local control in elections, citing California's panic over a successful grassroots effort to implement paper ballots and hand counting in one county.

- Dr. Frank encounters resistance from Chinese immigrants in Massachusetts who are awakened to the situation in the US and want to help, illustrating the spread of his message and the need for action.
- **Canvassing for voter fraud detection. 50:38**
 - Frank explains how canvassing can uncover election fraud by targeting suspicious households and eliciting responses from homeowners.
 - Douglas Frank emphasizes the importance of canvassing as a way to uncover actual voter fraud, citing personal experience in Pennsylvania and Georgia.
 - By presenting evidence of fraud directly to the public, canvassers can build a "nice pile" of cases and eventually overwhelm the ability of election officials to withstand the evidence, leading to positive change.
- **Election integrity and fraud in Louisiana. 54:24**
 - Douglas Frank tells a story about a speech he gave at the **Louisiana GOP event**, where he presented data on election fraud and vulnerabilities after a previous speaker's positive speech.
 - Douglas Frank explains election processes to a group of **[SOS--KYLE ARDOIN] colored citizens**, with one attendee expressing confusion over fraud.
- **Election hacking and decertification. 57:24**
 - Douglas Frank claims to have remotely accessed and manipulated election systems in Louisiana with the help of a friend.
 - **Douglas Frank [SOS--KYLE ARDOIN]**, Louisiana Secretary of State, plans to decertify election machines before 2022 election.
 - Michael Lindell offers to help with transition to new machines, but plan is delayed and ultimately fails.
 - **Douglas Frank [SOS KYLE ARDOIN] denied meeting with a whistleblower, but a dozen affidavits proved he had.**
 - **Frank [SOS KYLE ARDOIN] resigned** after the affidavits were presented, admitting he was hacked and his friends were lying about him.
- **Election fraud and cybersecurity. 1:03:40**
 - Douglas Frank shares his experience with the FBI and discusses the potential for hacking of election systems through the **Albert Censors**.
 - Douglas Frank discusses Tina Peters' stand against election fraud and the legal consequences she's faced.
- **Election integrity and machine verification. 1:07:00**
 - Douglas Frank refers to himself as the "Johnny Appleseed of election integrity," citing his efforts to promote free and fair elections across the country.
 - He expresses frustration with the lack of understanding between "innies" and "Audis" (presumably referring to political ideologies) and encourages listeners to get involved in the democratic process.
 - Douglas Frank discusses his involvement in various events related to election fraud, including the "Moment of Truth" summit and the "Election Crime Bureau" summit.
 - Frank mentions that representatives from every state spoke at the "Moment of Truth" summit, including a representative from Georgia, Gavin, who spoke on behalf of the state.
 - Douglas Frank discusses his plan to show whether voting machines are online or not, using a device that can detect radio transmissions.
 - Frank believes this will be a huge win for him **[if the legislators made it illegal to use devices that can detect radio transmissions]** and could potentially lead to legislators making it illegal to interfere with the signal.
- **Election fraud and data analysis. 1:14:45**
 - Douglas Frank shares his personal experience of meeting with Wisconsin Speaker Robin Vos and other officials to discuss election integrity.

- Frank highlights the importance of data analysis in understanding election issues, and plans to show examples from Wisconsin, Wyoming, and the listener's own state [Georgia].
- **Election fraud in Wisconsin. 1:17:19**
 - Douglas Frank shares evidence of widespread fraud in Wisconsin, including an email from the County Clerk of Milwaukee admitting to backdating absentee ballot applications.
 - Sean Smith interrupts Frank's summary, questioning the amount of fraud found, and Frank responds by pointing out that recounts in large counties have consistently shown fraudulent ballots.
- **Election fraud and manipulation in the US. 1:20:25**
 - Dr. Frank shows data on voter rolls in Wisconsin's largest counties, revealing surges and drops before elections.
 - Dr. Frank reveals Wyoming's voter rolls are inflated by 20-25% every two years.
 - Dr. Frank emphasizes the importance of local elections and how they can impact the country more than national ones.
- **Election reform and potential for fraud in Wyoming. 1:26:39**
 - Douglas Frank claims Wyoming legislators are incapable of passing election reform due to their party's internal divisions.
- **Voter rolls and election integrity. 1:29:09**
 - Douglas Frank_Dr.-DGF explains that voter rolls in Kentucky had to be cleaned due to excessive growth rate compared to population, with over 100,000 people removed from rolls in 2019 before the 2020 election.
 - Frank highlights that there are 350 counties in the US with more people on voter rolls than actual population, with Judicial Watch suing these states and winning lawsuits to remove ineligible voters.
 - Douglas Frank claims that voter rolls in Kentucky and Los Angeles are being manipulated by replacing removed names with new ineligible voters.
 - Douglas Frank shows election data for Georgia, revealing number of registrants in every election from 1996 to 2022.
- **Voter rolls and election trends. 1:35:34**
 - Douglas Frank claims that voter rolls in the US are inflated by 20% due to artificial growth, with 1 in 5 people in the roles not belonging there.
 - Frank suggests that this is due to laws that allow for the registration of non-citizens and the use of voter machines, which have made elections more volatile and led to a massive turnout in the 2018 midterms.
- **Voter rolls and voting patterns in Georgia. 1:38:35**
 - Douglas Frank highlights the rapid growth of voter rolls in Georgia, particularly after the implementation of motor voter laws, which have resulted in a uniform voting pattern across counties.
 - Frank uses a graph to show the percentage of people voting in each county in past elections, demonstrating how centralized control has led to a uniform voting pattern across all counties.
- **Voter rolls and election integrity. 1:41:16**
 - Douglas Frank highlights the issue of dirty voter rolls in the US, with 30% of voters not being real people.
 - He shows a table with 2.2 million excess people in voter rolls across 159 counties, matching canvassing findings of non-resident voters.
 - Douglas Frank highlights the discrepancy between Clayton County's population and registered voters, particularly among older age groups.
 - Frank hypothesizes that the difference may be due to the county's failure to clean its voter rolls, potentially leading to fraudulent voting.
 - Douglas Frank assumes the ratio of active voters to population is the same in all Georgia counties, predicting election outcomes based on this assumption.

- He uses software to test this assumption, finding that the predicted curves for different counties resemble the actual curves, suggesting inflated voter rolls may be used to manipulate election outcomes.
- **Voter data analysis in Montana. 1:49:47**
 - Douglas Frank highlights discrepancies in voting patterns in Missoula, Montana, using voter rolls and election data.
 - Douglas Frank claims he can predict the shape of every county in Montana based on mail-in ballots.
- **Election fraud and ballot stuffing. 1:52:56**
 - Douglas Frank criticizes a movie about election fraud for not addressing the root causes of the issue.
 - Douglas Frank claims that NGOs in Arizona are receiving absentee ballots from students at UCLA who are paid \$200 per ballot for organic harvesting.
 - Douglas Frank claims that 40% of ballots are missing or unaccounted for, with 20% coming from organic harvesting and 40% from the post office.
 - Frank suggests that mail carriers or janitors may be taking missing ballots and selling them for \$45 each, totaling \$13,000 in missing ballots from one county in Nebraska.
- **Voter fraud and ballot stuffing. 1:59:48**
 - Douglas Frank claims that the Center for Tech and Civic Life (CTCL) is funding the distribution of fraudulent ballots in multiple states through a network of non-profit organizations.
 - Frank asserts that every ballot has a name assigned to it, and his team helps identify the real voters and prove that the ballots are fraudulent.
- **Money, politics, and society. 2:02:43**
 - Douglas Frank Dr.-DGF and others discuss potential sources of foreign money influencing US society.
- **Voter registration and election turnout in the US. 2:04:47**
 - Frank emphasizes the importance of being "annoying" to spread truth and build a movement.
 - Douglas Frank Dr. DGF addresses a question about when a confrontation started, sharing a personal experience of being polite to an annoyed woman.
 - In 1996, there was a significant increase in voter turnout in the US, with 30 million more votes cast than expected based on population growth.
- **Voter registration and election fraud. 2:10:39**
 - Douglas Frank claims that in Montgomery County, Pennsylvania, 50,000 people were added to the voter rolls in 1996, but none of them voted in any subsequent elections.
 - Frank believes that this is evidence of widespread voter fraud, with people being added to the rolls across the country who are not real voters.
- **Election fraud and voter manipulation. 2:13:12**
 - Douglas Frank claims that he has evidence of election fraud in multiple states, including Georgia, Arizona, and Pennsylvania, and shows a graph to support his claim.
 - Frank compares the 2016 and 2020 election results in each state and notes a significant shift in favor of the Democratic candidate, Joe Biden, in almost all states.
 - Douglas Frank claims that in 2016 and 2020, white hat hackers launched denial of service attacks on election machines, causing delays in reporting election results.
 - Frank provides an example from Michigan, where 256,000 new voters were added to the rolls after the machine was turned off and back on, and the Voter IDs for these new voters were found to be fraudulent.
