Hi Leelanau County Commissioners, Clerk, Supervisor, Prosecuting Attorney, and Sheriff,  
(Plus 251 additional County & Township Administrators, employees, and Board Members):

I've ATTACHED our three most recent files (#'s 11, 12, & 13) showing election fraud in the 2020 Election.

Also, I've recently **added 336 Leelanau County School Educators** to the TCFamily.org email list (bringing the email list up to nearly 600 Leelanau County leaders when we add in the current 262 Leelanau County Government workers and Board Members).

With the new Educators list in mind, I've **ATTACHED our "About TCFamily & LGBTQ" flyer** to warn them ('If you see something, say something') about the false foundation of the 'LGBTQ' Movement (click on the "Pink Swastika"; "Alfred Kinsey"; and "The 1973 APA Born 'Gay' Hoax" links on the front left column), and the marketing techniques (click on "Kirk & Madsen's 'After the Ball' Media Manipulation game") that are used – especially in many schools – to groom the children into the 'LGBTQ' Movement.

I also attended all of the 'Up North Pride' "Pride Week" events (except the swimming night) this past week, and I was glad to see that even though many of the LGBTQ-identifying people disagreed and voiced their opinion with me giving out my ATTACHED new "About TCFamily & LGBTQ" flyer at their events, **they all knew that in America we all have our First Amendment Right to Free Speech, even when that speech might be unpopular.**

All of the 'LGBTQ' people plus their so-called allies that is, **except one young man (with a large "Up North Pride" logo on his sweatshirt) who decided that I should not have the right to talk to them and display our 4'-wide "The Rainbow Belongs to God" sign and hand out our "About TCFamily & LGBTQ" flyers.** So as he exited the Up North Pride Celebration Open Space gate (where I was handing out our Flyer) he grabbed my sign out of my hands and gleefully ran away and bent it all up. Then two men Patriots (who I have never met) rode after him on their bicycles and encouraged him to just give the sign back. He refused, and then threw my sign in the bay, plus the cell phone of one of the two men. They stood by him to make sure that he did not run away until the police arrived (I had called 911 when I saw him trying to destroy my sign.)

The next day Sunday 10/2/22 I again went to the entrance of the 'Up North Pride' Open Space brunch to hand out my flyers. **One of the female leaders of 'Up North Pride'** came out to the gate to me with my now noticeably creased "The Rainbow Belongs to God" sign, saying that someone had fished the sign out of the Bay so that they could return it to me. I took the opportunity to compliment all of the 'LGBTQ' folks that I had displayed my sign to and offered my flyer to, and how they all had allowed me to have that free speech (except that one young man, who hopefully has learned a lesson in tolerating something or someone he disagrees with.) She agreed that 'Up North Pride' is all about allowing free speech. And we both happily shook hands.
