


### **53 Calls for Service in November**



#### TOTAL CALLS FOR SERVICE 539 YEAR-TO-DATE


### MONTHLY CALLS BY TOWNSHIP




## YEARLY CALLS BY TOWNSHIP



I IN 5 CHRISTMAS TREE FIRES ARE CAUSED BY HEAT SOURCES TOO CLOSE TO THE TREE. MAKE SURE THAT YOU HAVE AT LEAST A 3 FOOT AREA BETWEEN YOUR TREE AND HEAT SOURCES LIKE FIREPLACES AND OTHER HEATERS.

REMEMBER TO WATER YOUR REAL TREES DAILY TO PREVENT THEM FROM QUICKLY DRYING OUT AND ONLY USE LIGHTS THAT HAVE BEEN LISTED BY AGENCIES LIKE UNDERWRITERS LABORATORY.

FOR THE NEW YEARS HOLIDAY MANY MAY FEEL THE NEED TO USE FIREWORKS TO RING IN 2025. PLEASE REMEMBER THAT ACCORDING TO THE NFPA, 31,000 FIRES ARE REPORTED ANNUALLY CAUSED BY FIREWORKS. MANY INJURIES ARE ALSO REPORTED EACH YEAR.

BOTH HOLIDAYS INVOLVE CELEBRATIONS BUT THAT CELEBRATION SHOULD BE DONE RESPONSIBLY. ACCORDING TO THE NTSA, DECEMBER IS ONE OF THE MOST DANGEROUS MONTHS WHEN IT COMES TO DRUNK DRIVING DEATHS. PLEASE BE



RESPONSIBLE WITH YOUR CELEBRATIONS SO ALL OF OUR FAMILIES CAN ENJOY THIS HOLIDAY SEASON.
