Gentlemen,

I write to encourage you to insist that Northgate Resorts modify their redevelopment plan for Leelanau Pines campground to preserve the character of Lake Leelanau.

My family has vacationed on South Lake Leelanau for over 35 years. We own lakefront property just a mile south of Leelanau Pines. My primary residence is in Keedysville, Maryland. One of Northgate's existing resorts, Yogi Bear's Jellystone Park Williamsport, is located in the neighboring town of Williamsport, Maryland, just a few miles from our home - https://jellystonemaryland.com/. Having spent years in Leelanau County while also living so close to an existing Jellystone resort, I may be uniquely qualified to compare Northgate's recreational model with the character of the peninsula.

A Jellystone style resort/RV park can be a great, cost-effective summer getaway in the right community. The scale, noise, lights, traffic, and logistical infrastructure, however, are all much more suited to a vacation experience in a larger town. Traverse City, Cadillac, or Grayling, for example, all have larger commercial districts consistent with the character of a Jellystone resort. The Yogi Bear park in Williamsport, MD is just minutes from two interstates, and near major commercial hubs with fast food, entertainment, and shopping. The Williamsport RV park fits with the character of its community.

The park that Northgate has proposed for Leelanau Pines, however, does not fit the character of Lake Leelanau, Centerville Township, or Leelanau County. Commercial lakefront pools, water slides, open-air pavilions, splash pads, etc. are not life on South Lake Leelanau.

I invite you to spend a few minutes watching the slide show at the top of Leelanau County government's web page (<u>www.leelanau.gov</u>). The slide show reflects how Leelanau County sees itself and markets itself to the world: sunsets, beaches, farms, lighthouses, orchards, lakes, dunes. Then visit <u>www.jellystonemaryland.com</u> and ask yourself whether Jellystone resort images belong in this same Leelanau County sequence. I think the answer is

clear.

If Northgate wants to redevelop Leelanau Pines, insist that the finished product fit the spirit of the slide show on the county's web site. Insist that their redevelopment reflect the character of the community they wish to join. Their current proposal does not.
