5. Report from Chris Grobbel on Williams Pumping

Grobbel can provide dates with interactions with the owner and Williams and Bay, dates of 2 observations, and he has personally informed them to stop.

The owners and Williams and Bay believe that they can inject the septage on the property because of 'right to farm.'

The letter to the Township was discussed. The Township also received comments of the public outcry about harmful waste and microplastics.

The Township's stance is for the owners and Williams and Bay to hold to the process and get a permit to inject waste on the Eitzen farm property.

Sequence of events (per Grobbel)

- 6-11-24 there was a complaint. Grobbel went to the property and took photos of waste being injected into the soil.
- Grobbel called Williams and Bay and informed them that they had to stop injecting waste into the property and get a permit. Williams and Bay informed Grobbel that their manager was on vacation. Bob Eitzen (owner) was informed.
- It has been confirmed that injecting the property with waste is happening again.
- The property owner and Williams and Bay were informed to cease and desist. The Ordinance was mailed to them.
- 6-14-24 The Township received a reply from their attorney that the activity is allowable under 'right to farm'.
- Neighbors are continuing to record when they see the property being injected with waste.

This is also going on at the Stachnik property.

This issue is in enforcement mode. Eitzen and Williams and Bay have been told that further injections will be fined \$500 per incident starting 6-11-24.

Thie first time injections were reported was 1-16-24.

At this point, all communication must go through the attorneys. We cannot contact them directly.

Their law firm has won a right to farm case in another township.

This is normal zoning enforcement. This ia a zoning procedure. Septage land application is regulated by the State.

6. Adjourn Meeting
