Hi to 598 Leelanau County Government workers and Educators:

I've been giving public comment evidence for election machine fraud at the Leelanau County Board of Commissioners Meetings for the last 18 months, and lately we've covered 3 different signs of machine algorithm fraud:

1. **Cast Vote Records:** Jeff O'Donell, in his Executive Summary in pages 10-21, shows that 128 counties out of 159 total counties (=81%) in 9 states (involving all 3 main types of voting machines – Dominion, ES&S, & Hart), all show major signs of voting machine fraud: <https://fingerprintsoffraud.com/>.
2. **2010 U.S. Census:** Dr. Douglas G Frank discovered that the 2010 U.S. Census is being used to determine both how many voters are registered to vote, AND how many ballots are cast, to .997 accuracy! Here is a large selection of his data: <https://electionfraud20.org/dr-frank-reports/>.
3. **Edward Solomon:** Shows absolute evidence of election fraud in every precinct in the two largest counties in Nevada (Clark = Las Vegas and Washoe = Reno), and says this same evidence shows the same fraud in both Oakland and Macomb Counties in Michigan (see the 13:40 time mark of the video).
