- 6. Report by Chair:
 - a. Chair Manikas summarized CREO Public Act 233 about local control about wind and solar. There are intervener funds available, not completely sure on all the details.

 - d. MOTION TO RECOMMEND FOR ADOPTION TO THE CLEVELAND TOWNSHIP BOARD SECTION 9.12 PARKS AND PRIVATE CONSERVATION NATURAL AREAS AND SECTION 9.13 PRIVATE FORESTS AS AMENDED BY STOWE AND SECOND BY SUTHERLAND. Motion passed 5-0.
