Whereas the Centerville Township Board of Trustees is committed to keeping the township hall in conformance with current safety standards and practices, and
Whereas the Centerville Township Board of Trustees makes the use of the township hall available to township residents for private functions as well as for township meetings and elections, and
Whereas the Centerville Township Board of Trustees recently remodeled the lower hall for meeting use and is now endeavoring to upgrade the upper hall, and
Whereas Mr. Michael Morin, Senior Risk Control Representative with Michigan Township Participating Plan, has recommended that the township "consider installing an emergency lighting system in the older portion of the Township Hall," and
Whereas the cost for emergency lighting has been determined to be \$272.00 for the lights and exit signs and \$374.00 for the installation for a total cost of \$646.00, and
Whereas the Centerville Township Board of Trustees is committed to pursuing outside funding for township expenses where appropriate and available,

Now, therefore, be it resolved that the Centerville Township Board of Trustees supports applying for a 50% grant not to exceed \$323.00 from the Michigan Township Participating Plan's Risk Reduction Grant Program.
