RESOLUTION OF THE CENTERVILLE TOWNSHIP BOARD

RESOLUTION NUMBER 97-/

- There is hereby created a planning commission to be known as the Centerville Township Planning Commission, pursuant to Act 168, P.A. 1959, as amended being sections 125.321 to 125.333 of the Michigan Compiled Laws, for planning commissions created under that act.
- 2.) The Centerville Township Planning Commission shall have all of the powers and duties as provided by law.
- 3.) The Commission shall be composed of five (5) members, who shall serve for a term of three (3) years and until their successors are appointed.
 - a.) The Planning Commission membership shall be representative of major interests as they exist in Centerville Township, such as agriculture, recreation, education, public health, government, commerce, transportation and industry.
 - b.) One member of the Centerville Township Board shall be a member of the Centerville Township Planning Commission.
 - c.) The term of each member shall be for 3 years, except that of the members first appointed, two shall serve for 1 year, two for 2 years and one for 3 years. A successor shall be appointed not more than 1 month after the term of the preceding commission member has expired. All vacancies for unexpired terms shall be filled for the remainder of such term.
 - d.) Members of the planning commission may be compensated for their services as provided by the Centerville Township Board.
- 4.) The Centerville Township Board hereby transfers to the Centerville Township Planning Commission all powers and duties provided by Act 184, P.A. 1943, as amended, being sections 125.271 to 125.301 of the Michigan Compiled Laws, for zoning boards created under that act.
