

False Alarms

False alarms include system malfunctions, smoke mistaken for steam, calls where we were cancelled prior to arrival and accidental alarm trips. In the month of September, we had 2 false calls – about 1% of our calls.

Call Staffing:

This chart provides the duty crew staffing levels for the number of incidents. Our minimum is two (at least one Paramedic). Several calls involved the response of paid-on-call staff.

Two FFs on duty: 6 (14%)
Three FFs on duty: 27 (61%)
Four or more on duty: 11(25%)

HAAS Traffic Alert Activations:

This chart provides the data surrounding the recent instillation of the HAAS Safey Cloud warning system in four of our apparatus (2 still awaiting the installation). The system allows us to track our fleet's location, traveling speeds, and number of vehicles that were notified by our apparatus when they had their lights and sirens on. In August:

- We alerted **333** total drivers through in-vehicle devices (vehicle navigation/detection systems, Waze® maps, or Apple® maps. So far we have alerted 1,082 drivers since we installed the system in July (2024).
- Our system detected 56 minutes of response time. This is captured by the number of
 minutes an apparatus is detected going lights and sirens from one spot to another (i.e.:
 from the fire station to a call, one call to another, or an incident transporting someone
 emergent from the scene to a local emergency room). The emergency response time from
 the start up of the apparatus and activating the emergency lights to the incident scene was
 4.7 minutes.
- Our system detected **31** minutes of on-scene time (e.g.: a fire department vehicle parked in or alongside the road warning approaching drivers of an incident with their lights on at a scene).

Vehicle Repair, Maintenance, Changes, or Information:

None noted.

Fire Prevention/Community Involvement:

- Continued installing smoke alarms (6) and carbon monoxide alarms (2), in Leland Township residences, in the month of September. T
- Built six (6) 9-1-1 address signs. These are sold by the *Leland Volunteer Fire Department* (LVFD)association.
- Provided fire and EMS coverage at the bridge walk events in both the villages of Leland and Lake Leelanau.
- Provided several tours or our facilities or apparatus upon request.
- Crowd manager training session at Lake Leelanau Station with 8 guests in attendance. This
 is designed for groups planning large special events in Leland Township.

- Began community-wide survey to identify driveways and private roads that require improvements to allow for FD apparatus access.
- Developed and sent out a directive to locations in violation of fire apparatus access parameters. Included was a tracking tool to follow up on directives sent to locations that needs improvement for fire apparatus access (in the event of an emergency).
- Followed up on directive sent to owners of a home on N. Manitou trial (abandoned property). The property has been confirmed as secured. Withdrew the directive and confirmed the same with the county.
- Completed comparative analysis of current fire response pre-plans as compared to the townships commercial business inventory. Continuing to clean up discrepancies between Blazemark pre-plans and all properties loaded into ESO.

Fire Station/Infrastructure:

- Had FireCatt perform our annual ground ladder and fire hose inspections as required. 5
 lengths of hose failed the inspection and they are slated to be repaired or replaced.
- Worked to free a clogged drain at the end of the apparatus ramp in front of the Leland Station. The duty crew performed the clean out in lieu of calling out a private business.

Miscellaneous Things Involving Our Department:

- Responded to a motor vehicle crash at the corner of M-22 and East Duck Lake Road (M-204)

 Duck Lake Corner. Leland Township Fire & Rescue personnel responded from the Lake
 Leelanau Fire Station and arrived to find two vehicles blocking M-22 south of the
 intersection. All occupants were assessed for injuries but declined to be transported. Fire
 department personnel assisted with traffic control and roadway cleanup until the vehicles
 could be removed from the scene by Bingham Towing.
- Promoted Lieutenant Chase Schelling to Captain and Firefighters Greg Johnson and Randy Rosselle to Sergeant. They posed below for several pictures.

Above and Below Left: Leland Township Firefighters, assigned to the Red Shift, work to clean up a clogged drain near the apparatus ramp where our fire trucks come in and out, at the Leland Station. The crew worked to unclog the drain, caused by grass overgrowth – covering the exit, and clean the system out. By doing this internally we were able to save the cost of having a third-party vendor do the work. Firefighters do projects in-house, whenever possible, to save some labor cost or delays in getting the work done.
